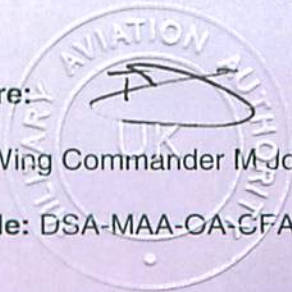

Trial Workup Flying	Flying training undertaken to an approved schedule, carried out to maintain, re-establish, improve, or check nominated aircrew operating skills, techniques or experience, in preparation for and a constituent part of, a specific flight trial.
Trial Support Flying	Flying carried out in direct support of a flight trial, or in direct support of a Test and Evaluation organization.
Test Pilot Training	Flying and ground training conducted towards the award of a Test Pilot Certificate of Competence carried out as part of an approved course of instruction at a recognised test pilot school ³ .
QualEval Flying	Flying during which a Test Pilot without a valid Certificate of Qualification on Type is allowed to handle an Air System to assess it, and to practice the skills required during the flight assessment of an Air System ⁴ .
Demonstration Flying	Flying designed to demonstrate the characteristics of an Air System and/or its systems.
Continuation Training	Flying training carried out to maintain, re-establish, improve, or check aircrew operating skills, techniques or experience.
Tasked Flying	Flying carried out in direct support of a non-flight trials related task or exercise.
Conversion Training	Flying and ground training conducted towards the award of a Certificate of Qualification on Type.
Maintenance Test Flying	Test flights conducted to confirm the performance and serviceability of an Air System or part of an Air System carried out in accordance with an appropriate Flight Test Schedule ⁵ .
Customer Flying Training	Flying training conducted as part of a contract for customer aircrew or supernumerary crew.
