RECALL OF AEROQUIP 601 TYPE HOSE

CLASSIFICATION

This Service Bulletin has been classified as Mandatory by the C.A.A.

COMPLIANCE

In accordance with Aeroquip Bulletin 002 RI

INTRODUCTION:

Slingsby T67 aircraft are fitted with oil and fuel hoses which are manufactured by Slingsby Aviation to their (Slingsby) own drawings. These hoses use Aeroquip 601 in their manufacture.

The purpose of this Service Bulletin SB 029 is to detail which hoses. as originally fitted to Slingsby T67 aircraft, are affected by Aeroquip Bulletin 002R1.

APPLICABILITY

Slingsby T67 GRP aircraft (T67M200, T67C and T67M-MkII) as indicated by Tables 1, 2 and 3, pages 2 and 3 respectively.

The tables detail aircraft construction number (C/N) and registrations, and show which hoses, as originally fitted, must be replaced under the terms of Aeroquip Bulletin 002R1.

ACTION:

Check Tables 1,2 and 3 (Fig. 1, 2 and 3 respectively for location)* for applicability. 'R' in the tables denotes that the hose requires replacement.

Aeroquip Ltd, Redditch, Worcestershire, have received copies of the relevant Slingsby hose drawings and will manufacture replacements accordingly.

Operators/owners requiring replacement hoses as detailed by Tables 1.2 and 3 should contact Aeroquip direct. Details can be found in Aeroquip Bulletin 002R1 which is reproduced on pages 7 and 8 of this Service Bulletin for completeness.

*Only replacement hoses are shown in figures.







SERVICE BULLETIN RECALL OF AEROQUIP 601 TYPE HOSE

This bulletin supersedes Service Bulletin No. 002 dated August 1988 which should be destroyed.



ONLY AEROQUIP HAS RED COLOURED SOCKETS

APPLICABILITY

- 1. This Service Bulletin is applicable to all Aeroquip type 601 hose used in fuel or oil systems which have a manufacture date of April 1984 to May 1988.
- 2. The hose can be found in the following forms:-
 - a) Hose assembly, manufactured wholly from Aeroquip parts, these can be identified by red sockets marked 516-XX or 516-XXX or covered in fire sleeve marked AE102/624 or AE102G.
 - b) Bulk hose identified by a white label with FSCM "50556" in red print with a cure date of 1Q84 through 3Q87.

note: It should be noted that the suspect hose may have been used in the manufacture of other hose assemblies, the identification of which is not readily apparent. In this case reference should be made to the original source, in order to establish whether the suspect hose has been utilised in its construction, so that the appropriate action can be taken.

REASON

Possible premature ageing resulting in leakage through the hose material. Undetected fuel or oil leakage may result in a fire hazard or system failure

DESCRIPTION

This Service Bulletin accomplishes the following -

- 1. Provides for inspection of all fuel and oil hose assemblies to determine whether the hoses fall within applicability above.
- 2. Replaces all suspect hose assemblies.

COMPLIANCE

- 1. As soon as practicable, but within a maximum period of one month from receipt of this Bulletin, identify and inspect all suspect hoses, unless already accomplished.
- As soon as practicable, but within six months of receipt of this Bulletin, replace all suspect hoses unless already accomplished
- 3. Repeat the inspections of hose assembltes at maximum intervals of one month until the terminating action in (2) has been completed.

This Bulletin is approved by Aeroquip Limited, Aerospace Division and its contents have been classified as mandatory by the C.A.A.
