3. HOW WE USE YOUR PERSONAL DATA

4. HOW YOUR PERSONAL DATA IS COLLECTED

6. DISCLOSURE OF YOUR PERSONAL DATA

We do not disclose your data to any third party.

7. DATA SECURITY

We have put in place appropriate security measures to prevent your personal data from being

accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit

access to your personal data to those employees, agents, contractors and other third parties who

have a business need to know. They will only process your personal data on our instructions and they

are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify

you and any applicable regulator of a breach where we are legally required to do so.

8. DATA RETENTION

We will keep your data for so long as there is a requirement to send correspondence to you, once

this requirement has ceased either at your request or otherwise we will delete your records from the

system.

9. INTERNATIONAL TRANSFERS

Your data will not be transferred by us to any other country.

10. YOUR LEGAL RIGHTS

At any point while we are in possession of or processing your personal data, you, the data subject, have the following rights:

- Right of access you have the right to request a copy of the information that we hold about you.
- Right of rectification you have a right to ask for data that we hold about you that is inaccurate or incomplete to be corrected.
- Right to be forgotten in certain circumstances you can ask for the data we hold about you to be erased from our records. If there is no overriding legal reason to keep it.
- Right to restriction of processing where certain conditions apply to have a right to restrict the processing.
- Right of portability you have the right to have the data we hold about you transferred to another organisation.
- Right to object you have the right to object to certain types of processing
- Right to object to automated processing, including profiling You have the right to ask for certain important computer-made decisions (including profiling) to be challenged and to ask for a human to intervene.

(Please note that at this time no automated processing of Personal Identifiable Information (PII) is in operation).

in the event that Marshall Group refuses your request under rights of access, we will provide you with a reason as to why.

You have the right to complain as outlined in clause 11 below.

11. COMPLAINTS

In the event that you wish to make a complaint about how your personal data is being processed by Marshall Group, or how your complaint has been handled, you have the right to lodge a complaint directly with Marshall Group's Data Privacy Manager, by emailing
